



## Participation Agreement, Release and Assumption of Risk

**This is a legally binding Agreement. By signing this agreement, you give up your right to recover compensation or obtain any other remedy arising from activities at KangArena, LLC.**

In consideration of the services of KangArena, their agents, owners, officers, volunteers, participants, employees, and all other persons or entities acting in any capacity on their behalf, and being allowed to enter KangArena, LLC facilities and/or participate in any activities at KangArena, I agree as follows:

1. I understand and acknowledge that the use of KangArena LLC facilities, inflatable devices, and any other amusement device entails known and unanticipated risks of serious bodily injury, physical or emotional. I have full knowledge of the nature and extent of the risks associated with the facilities and activities.
2. I expressly agree and promise to accept and assume all of the risks existing in this activity. My participation and all whom I am supervising is purely voluntary, and I elect to participate in spite of risks.
3. I hereby voluntarily release, forever discharge, and agree to indemnify and hold harmless KangArena, LLC from any and all claims, demands, or causes of action, which are in any way connected with my participation in this activity or my use of KangArena equipment, services, or facilities, including any such claims which allege negligent act or omissions of KangArena, LLC.
4. Should KangArena LLC or anyone acting on their behalf, be required to incur attorney's fees and costs to enforce this agreement, I agree to indemnify and hold them harmless for all such fees and costs.
5. I certify that I have adequate insurance to cover any injury or damage I or those persons under my supervision may cause or suffer while participating, or else I agree to bear the cost of such injury or damage myself. I further certify that I am willing to assume the risk of any medical or physical condition I may have.
6. In the event that I file a lawsuit against KangArena, I agree to do so solely in the state of Louisiana, and I further agree that the substantive law of that state shall apply in that action without regard to the conflict of law rules of that state. I agree that if any portion of this agreement is found to be void or unenforceable, the remaining document shall remain in full force and effect.
7. I will observe all rules and regulations of KangArena LLC, and although adherence to rules, use of safety equipment, and personal discipline reduces the risk of injury, I realize that the risk continues to exist. I agree that if I observe any hazard during my participation, I will promptly bring it to the attention of the nearest KangArena, LLC staff member.
8. I do hereby authorize Kangarena and its assigns to utilize any and all photographs, pictures or other likeness of me or anyone assigned guardianship to me, as they deem appropriate in its promotional materials or team films.
